INSURANCE GUIDELINES TO OBTAIN AUTHORIZATION

All insurances are not the same. Some require that you call, while others you are able to obtain on-line. The requirements that are the same across the board are below.

REQUIRED documents you will need when obtaining an authorization:

1. Patient Demographics
2. CPT's of all tests you are requesting
3. ICD10 codes along with description
4. Current patients history and documentation of prolonged diagnosis

After submitting an authorization, the case may go peer-to-peer. This means you will need to have a nurse, PA or the referring Doctor contact the insurance company.

If you would like SDMI to obtain authorization for you, write "PLEASE OBTAIN AUTH" at the top of your referral and send with all of the required information listed above. The insurances noted in **GREEN** will not allow SDMI obtain authorization. It must come from the referring doctor due to contractual agreements.
